2. Cotton Yarn Count 2/20S (cotton yarn should be organic natural Fibers with 100% purety).
3. Cotton Yarn Count 10S (cotton yarn should be organic natural Fibers with 100% purety).
4. Cotton Yarn Count 2/40 (cotton yarn should be organic natural Fibers with 100% purety).
5. Cotton Yarn (Dyed)
6. Woolen Yarn 2/48 (Dyed).
7. Woolen Yarn 2/48 White.
8. Woolen Yarn 2/36 (White)
9. Woolen Yarn 2/36 (Dyed)
10. Cashmilone 2/32 (Dyed)

1. Tenders should be addressed to the undersigned.
2. The Tenders should be super scribed "Tender for the supply of Yarn".
3. Tenders should be duly accompanied with the Earnest Money of Rs. 100000/- (Rs. one lakh ) only in the shape of Bank Draft, in favour of the "Himkaara Unnayan Smiti" Registered/Head Office District Jail Shimla or duly pledged Fixed Deposits Receipts. However, further regulation of the Earnest Money will under the provision of HPFR-2009. No Tenders will be accepted without the requisite Earnest Money
4. The party whose Tender is approved for the supply will also have to execute a Contract Agreement within a fortnight from the date of award of letter.
5. Telegraphic/conditional Tenders will not be accepted.
6. The supply shall have to be made within 21 days from the date of issue of the supply orders.
