

**Organization, Function and Duties**

**Point No. -1: ORGANIZATION OF ENFORCEMENT WING, NAMES AND TELEPHONE NUMBERS OF OFFICERS.**

**A. Organization of Enforcement Wing:-**

The Department of Enforcement was created in 1981 vide HP Govt. Notification No. Per(Vig)F-1(1)81 dated 28.2.81. The need for setting up of a separate department of Enforcement was felt because Vigilance Department could make enquiries and register cases in which only public servants were suspected to have abused their official position to facilitate wrongful gain to themselves and corresponding loss to the State. The Vigilance Department was not empowered to register or investigate cases under Local and Special Enactments such as Indian Forest Act, Excise and Taxation Act, Essential Commodities Act etc. nor was Vigilance Department empowered to take cognizance against private individuals/contractors. The Directorate of Enforcement is presently headed by ADGP and assisted by IGP and DIG Enforcement. It has two zones viz North Zone and South Zone with Zonal hdqrs. at Shimla and Dharamshala and one administrative wing at Shimla. The Zonal Hqrs. at Shimla and Dharamshala are headed by SPs. Whereas the administrative wing is headed by SP(Administration). It has two police stations, one at South Zone, Shimla and other at North Zone, Dharamshala. The Police Station South Zone Shimla comprises districts of Shimla, Solan, Sirmour and Kinnaur, whereas Police Station, North Zone, Dharamshala comprise districts of Kangra, Chamba, Una, Mandi, Kullu, Hamirpur, Bilaspur and Lahoul & Spiti.
